Objectives and aims of the workshop

Research indicate that as multinational companies become more internationalized in their operations and management structures, unions at supranational level are increasingly having to internationalize their perspectives and strategy within companies. This provides new challenges of linking different traditions and practices of national and local trade unionism, rooted as they are in the workplace. Hence, an examination of union strategies of intervention at European level needs to include an analysis of the differences in the diverse national union positions towards Europe.

The workshop aims to provide an opening base discussion on the diverse national union positions and attitudes towards Europe as well as on union policy and strategy at both local and national, and European/international levels in order to examine prospects and constraints of union internationalism. What does it mean to be European for national trade unions today? How can a European dimension to trade unionism be defined and developed? What kind of socio-political and legal framework is European trade unionism based on?

Developing a robust analysis of the issues in question necessarily involves an international and comparative approach. By bringing together international scholars and experts interested in labour, the workshop will provide a basis for wide-ranging and rich discussion on the themes of Europeanisation and international labour. In particular, debate will focus on assessing the extent of trans-national trade union co-operation while discussing employee representation, participation and democracy at work as potential mechanisms for deepening such co-operation. What can the role of collective bodies and systems of employee participation and representation at EU level (i.e. European Works Councils, EU statute regulating company law or European Company Statute) be with regards to creating effective European, and even global, networks of employee representatives and trade union co-operation across borders? Is there a space to articulate between national/local and European levels of employee representation and trade union organisation and (if any) how and why?
